## IN THIS HOLIDAY SEASON, TO AVOID HUMANE SOCIETY SCAM, GIVE LOCALLY

If you back a wild animal into a corner, you run the risk that it will lash out. That's also the result when an animal rights group is exposed for misleading Americans and scamming them out of millions of dollars that could have helped pet shelters.

Nowhere in the recent ad hominem attack piece written by the Humane Society of the United States against my organization, the Center for Consumer Freedom, will you find the group rebutting this simple fact: Less than 1 percent of HSUS's budget is donated to local pet shelters or humane societies to help them care for animals.

Don't take my word for it. The director of

the Newark-based Associated Humane Societies told News 12 that her group receives "not one penny. We receive nothing from (HSUS). And the amount of money they get nationally and don't share with needy shelters like ours is a shame."

The Humane Society of the United States collected \$131 million in 2010, but could

apparently only spare \$500 to help New

Jersey's animal shelters. It is likely that HSUS raised hundreds of thousands, if not millions of dollars from the Garden State. Yet almost none of it was given back to the community.

HSUS responds that it "never says" that it gives to local shelters. But knowing people are confused, they also never set the record straight.

According to a recent national poll, 71 percent of Americans incorrectly believe that HSUS is an umbrella for the nation's local pet shelters. Nearly six in 10 Americans think HSUS shares most of its money with pet shelters.

HSUS is well aware of this widespread

## THREE COUNTIES AWARDED EMERGENCY PET TRAILERS

Three animal emergency trailers were awarded to Bergen, Hudson, and Morris counties by the New Jersey Department of Agriculture at a ceremony in West Trenton in October.

These 20-foot trailers are to be used in emergency situations to set up temporary animal shelters. They are outfitted with cages, heating and cooling units, electrical and water hook-ups, generators and external light sources.

"New Jersey, located between two major cities, needs to be prepared in case disaster strikes, because any incident that poses a threat to large numbers of people is likely to put animals at risk, as well," said New Jersey Secretary of Agriculture Douglas H. Fisher, who awarded the trailers to the counties' Offices of Emergency Management and County Animal Response Teams. "The animal evacuation trailers can fill a vital role in an emergency and help provide care for animals that might not be able to go along with their owners."

Paid for with an Urban Areas Security Initiative Grant, the trailers will be used by the counties' Animal Response Teams, whose members are trained on animal issues in disasters. The trailers will allow owners to seek shelter for themselves in the face of an emergency, without having to worry about their pets.

**Recording Secretary-** The May minutes were reviewed, Joyce Wilson made a motion to accept the minutes, seconded and approved. The October minutes were reviewed and Joyce Wilson made a motion to accept the minutes, seconded and approved.

**Treasurer's Report-** Checking \$39,208.30 the dollar amount is high now as several bills from point show will be paid shortly. The Board voted to donate \$100 to each VFW in honor of Veteran's Day.

**Pet Therapy-**All is well, there are a new School in Oakland and one in Mahwah that is opening in January.

**AKC Delegate-**The Board of Directors has nominated the following Delegates as candidates: William J. Feeney ( Sir Francis Drake KC), Thomas Powers (Kennel Club of Beverly Hills), Lynn Worth Smith (Vizsla Club of America) The following have been named by Petition: Patricia Cruz (Heart of Plains KC), Larry Sorenson (Dachshund Clun of America), Robert Schroll (Clarksville KC). As of January 1, 2012 the AKC will increase the registration fee to \$30 per dog. With the first-time individual dog registration as well as any subsequent transfer of dog ownership, one primary owner will be listed with the \$30 registration or transfer fee. In addition, a \$10 fee will be added for each additional owner listed on the registration certificate. The primary owner will receive the

official AKC Registration Certificate and each additional owner will receive an email only copy of the registration certificate. The email copy will be clearly marked COPY, will not display the certificate issue date and will not have the transfer form on the back. The group club moratorium has been lifted for shows as long as it is run within an existing show. There will now be "Open Show" starting mid 2012. An Open Show is an informal AKC sanctioned confirmation event at which Championship points are not earned but rather Certificate of Merit (CM) points are awarded to this introductory AKC confirmation suffix title.

**Constitution on By-Laws-**A meeting has been scheduled by the Board to review. The AKC has already accepted our changes, once the Board reviews that, it will be presented to the Membership for Vote.

## FDA WARNING

November 18, 2011 — The U.S. Food and Drug Administration has issued an important bulletin warning consumers that chicken jerky products (also marketed as chicken tenders, strips or treats) may be associated with serious illness in dogs.

Over the past 12 months, the FDA has observed an increase in the number of complaints regarding canine illnesses associated with consumption of chicken jerky products imported from China.

These complaints have been reported to the government by both dog owners and veterinarians.

FDA had previously issued a cautionary warning regarding chicken jerky products in September 2007 and a Preliminary Animal Health Notification later on in December of 2008.

Unfortunately, so far, scientists have not been able to determine a definitive cause for the reported illnesses. The FDA continues to conduct extensive chemical and microbial testing but has this far not identified a contaminant.

### What to Watch For

Chicken jerky products should never be considered a substitute for a balanced diet. These treats should be intended to be fed only occasionally — and in small quantities.

The FDA is advising consumers who still choose to

feed their dogs chicken jerky to monitor their animals closely for any or all of the following signs that may occur within hours to days of feeding these products including:

- Decreased appetite
- Decreased activity
- Vomiting
- Diarrhea (sometimes with blood)
- Increased water consumption
- Increased urination

Blood tests may indicate kidney failure. And urine tests may show Fanconi syndrome (increased blood sugar). Although most dogs are likely to recover, some deaths have been reported.

### What to Do

If a dog shows any of these signs, the FDA urges consumers to stop feeding the suspected products immediately.

Owners should consult a veterinarian if signs or symptoms are severe or persist more than 24 hours.

So, take precautions. And be sure to tell everyone you know.

Ideally, every club would purchase a couple of tickets and give or sell them to their members to enabling them to attend. Our goal is to have forty attendees. This is a simple goal, but we need your assistance. The cost of each ticket will be in the \$30.

confusion. HSUS could make it explicitly clear in its fundraising appeals that it is not affiliated with local humane societies, that it gives almost no money to local shelters.

But HSUS doesn't. In fact, its fundraising helps perpetuate the confusion among Americans.

A review of HSUS' TV appeals reveals that more than 90 percent of the animals depicted are dogs and cats. HSUS' fundraising mailers are chock full of pets and have included lines such as "Your renewed membership helps the HSUS assist local shelters" and rhetoric about "saving these innocent puppies and kittens and finding them good loving homes."

It's no surprise that Americans mistakenly believe that the HSUS is a pet-sheltering group. In fact, my organization regularly hears from HSUS donors who are shocked to learn the truth about HSUS — that the group focuses more on attacking farmers who raise chickens and pigs rather than helping abused and abandoned cats and dogs.

Even more cynically, HSUS cites pet euthanasia statistics in its ads. Three to four million cats and dogs are put down in shelters every year. HSUS even acknowledges that shelters may be putting down more animals in these hard economic times.

And yet, HSUS is apparently all too happy to cite these statistics knowing that 99 percent of the money it raises won't go to grants that help pet shelters care for more animals and keep them alive.

Here's another inconvenient truth: When HSUS sucks up all these doggie dollars from local communities, the donations are used in ways that donors likely have no clue about.

Since 2004, HSUS has pumped \$14 million into executives' retirement pensions. And they have tucked \$32 million away in hedge funds, where the money can't help any animals.

Maybe pet shelters and homeless dogs and cats need a "We are the 99 percent" campaign.
