### **General Meeting Minutes**

The meeting was called to order at 8:10 p.m. by Vice President, Joanne Silver.

Recording Secretary: Pat Paladino advised minutes for January, 2003 were printed in the GROWL. Minutes approved as published, Jack Berlet and Joyce Wilson.

Treasurer: Jackie Makoujy advised that the checking account balance is \$14,836.11:  
Money Market Account balance is \$18,975.29.

Corresponding Secretary: Shirley Irwin received a letter from the Raritan River Akita Club donating 8 Ranapo Kennel Club patches to the Club. They appreciate the support of Ramapo at our show each year.

A letter from the AKC was received regarding the Nova Scotia Duck Tolling Retriever and the breed has been approved for competition effective July 1, 2003. The breed will be part of the Sporting Group.

AKC correspondence was also received regarding the changing of a judging panel.

AKC Representative Rose Radel reported that the transfer fee has been reduced from \$15.00 to \$5.00.

A six class program is available to community programs, schools and 4H clubs from the AKC about the responsibility of dog/pet ownership.

Sunshine: Lorraine Fennemore advised that Ruby Kleinmann's had surgery recently and the club sent her a card and fruit basket.

Vivian Bregman has hip replacement surgery about one month ago and she is doing well. The club also sent her a fruit basket.

Cyril Bernfield passed away approximately 3 weeks ago and Harry Hackoun is ill with heart problems.

Point Show: Ruth Henningsen reported that application has been made for Sunday and Monday, making Ramapo a 2 day show in conjunction with Palisade Kennel Club on Saturday. Palisade did not receive approval for a Friday show. Ruth is now awaiting AKC approval.

Diane Ammerman questioned whether we will be raising our entry fees. Ruth stated that the entry fee last year was \$23.00 and it will be raised to \$24.00 for 2003.

Also asked was whether there would be a reduced puppy entry fee (?) Ruth advised that it will be discussed at the Working Board meeting.

At the meeting with Palisade Kennel Club, the class for Veterans was discussed. We are losing money and entries for this class are down. We would like to constitute a "puppy class", Puppy Group and Best Puppy for the Sunday show.

Also brought up was charging at least \$1.00 or \$2.00 per car for parking. Could the club charge more than \$2.00? Ruth stated she will also discuss this at the next Executive Board meeting.

Match Show: Christine Haycock stated that she sent the ~application to AKC and has not heard anything to date, She will wait to the end of the month and if she still has not heard anything she will contact the AKC.

Awards: Elaine Barone reminded the members that forms for the yearly awards are available on the back table. Also letters should be submitted for the Ramapo Good Sportsmanship Award.

Candy Wisnieski stated that the Beginner Puppy Classes are filled. The gross amount received is approximately \$3,700.00 from the Obedience classes.

Also discussed was the admission age for Puppy Kindergarten, immunizations required?

Joy Messinger advised that show handling classes are picking up and new beginners class is starting this week. Joy also had a problem with the setting up of tables at the training hall. Candy will speak with the hall people.

Hi All,

My name is Dot Sweeney, I have the Black Russian Terriers you may have seen in the show ring. I am trying to get this to as many people as possible so if you would all be kind enough to send it on we may be able to have something done if enough people are concerned about the problem.

Two weeks ago I had my six week old litter of pups vaccinated with the new modified version of PROTECH DURAMUNE C4 and nearly lost all of them, one little boy died. I have since been talking to people in Victoria who have had problems with this new version of the vaccine. I believe there have been quite a few litters in Victoria that have experienced the same problems. The only thing the company will say is "there has been a problem with a small number of pups" but they are saying the other problems are not connected to the vaccine. The company says that reaction to the vaccine is over in a couple of days and anything after that is not connected. I have been told of a couple of people losing half of their litters after vaccination with this new version. What seems to be happening is that the reaction is so severe that the pups immune systems are depressed to the stage that they can not cope with anything else that would normally not bother them and that leaves them open to severe depression, bowel bacteria or pneumonia or Coccidiosis parasites which cause massive dysentery and dehydration and then death. This can hit 5-10 days after vaccination so most vets are not connecting it and only now are some realizing that the connection is there as it is happening too often. This vaccine is pretty new and a lot of vets are still using up supplies of the older version and have not used the new one so far. Believe me after the last two weeks it is not something I would wish anyone else to go through, I fought like hell to pull mine through, 2 on the drip at the vets and no sleep for 3 days to keep the others rehydrated, not to mention the vet bills at the end of it all. Please talk to your vets about this as a lot of them have not started to use this new version yet and pass this on to everyone you can think of in the dog world. If enough people refuse to use this vaccine they may pull it off the market and save a lot of suffering for our pets and ourselves. It would be good to get a list of people who have had a problem after using this vaccine to present to the company that makes it.

## **Ten Things You Need to know to Prepare Your Dog for a Disaster**

For pet owners faced with a flood, fire, hurricane, earthquake, or other crisis, disaster experts are all of one mind on what to do:

Take your pets with you.

While animals are not allowed in disaster-relief shelters, an increasing number of animal shelters and veterinarians are better prepared now than ever before to take in animals during an emergency.

In fact, a model program started by the California Veterinary Medical Association has a veterinarian in place in each county to help coordinate animal-relief efforts. Other states are starting to see the light, too, with veterinarians, shelter groups, and specially trained disaster teams from the Sacramento, Calif., based United Animal Nations are prepared to do for animals what the Red Cross does for people.

Why all the changes? A growing realization that animals need help, too, and that some people choose to put their lives in danger rather than abandon their pets.

So take your pets. Also take their food, leashes, medicines, blankets, and carriers if told to evacuate.

You do can do better, still, if you plan ahead. Here are some tips from disaster-planning experts.

### **1. Have a Plan**

Prepare for all possibilities, including the possibility that you may be away from home when disaster strikes. Make sure that everyone in your family, children, too, is prepared in the event of an emergency. Make a plan and go over it until every one knows what to do.

People need to rely on each other during emergencies, and this is just as true when it comes to your pets. Get to know your neighbors, and put a plan in place to help each other out. Find out from local shelters and veterinary organizations what their emergency response plans are and how you fit into them in case of a disaster.

### **2. Know What Your Veterinarian's Plans Are**

Ask your veterinarian if he has a disaster plan, and how he plans to fit in with other veterinarians in an emergency. If he has never thought of it, pushing him a little on the subject wont hurt. If he has no interest, consider changing vets or exploring back-up care for your dog from someone who is more tapped in.

### **3.Maintain Your Pet's Permanent and Temporary ID**

Most animals will survive a disaster. But too many will never see their families again without a way to determine which pet belongs to which family. That's why pets should always wear a collar and identification tags. Better still is permanent identification that can't slip off, such as a tattoo or imbedded microchip.

Keep temporary ID tags at hand, too, to put on your pet if you're forced to evacuate. (Your pet's permanent ID isn't of much use if you can't be home to answer the phone.) One of the easiest: Key tags on which you can jot a current number, slip into a plastic housing, and then attach to your pet's collar.

#### **4. Keep Vaccinations - and Records – Current**

Infectious diseases can be spread from dog to dog through floodwaters, which is why keeping pets vaccinations up-to-date is essential. Kennel cough, although not serious, is common in sheltering situations and also preventable through vaccinations.

Prepare a file with up-to-date medical and vaccination records, your Pets' microchip or tattoo numbers, your veterinarian's phone number and address feeding and medication instructions, and recent pictures of your animals. Trade copies of emergency files with another pet-loving friend - it's a good idea for someone else to know about your pet should anything happen to you.

#### **5. Have Restraints Ready**

Even normally obedient dogs can behave rather strangely when stressed by an emergency. Consequently, you should be prepared to restrain your pet - for his safety and the safety of others.

Keep leashes and camera ready for emergencies. Ready means at hand - the means to transport your pet shouldn't be something you have to find and pull from the rafters, harnesses work better than collars at keeping panicky pets safe.

Shipping crates are probably the least-thought-of pieces of emergency equipment for pet owners - but are among the most important. Sturdy crates keep pets safe and give rescuers more options in housing pets. They give you more options, too, in the homes of friends or relatives, or in shelters outside of the area.

Depending on weather conditions, crated pets may also be safely left overnight in vehicles.

Another item to keep on hand is a muzzle, because frightened and injured dogs are more likely to bite.

#### **6. Rotate a Supply of Food, Water, and Medications**

Keep several days' worth of food and safe drinking water as well as any necessary medicines packed and ready to go in the event of a disaster. Rotate your supplies so they do not get stale. If your pet eats canned food, be sure to keep an extra can opener and spoon tucked in among the emergency supplies.

## SAMPLE WILL CLAUSES

**EIGHTH,** If my wife shall predecease me or if we should die in a common accident, I hereby direct my Executor to immediately notify the Hudson Valley Humane Society, 150 McNamara Road, Spring Valley, New York 10977 who shall provide for the care of my animals until my executor shall have implemented and funded the Trust for my animals contained in Paragraph NINTH hereof. I direct my Executor to pay, as an administration expense, all expenses associated with the feeding and care, including veterinary costs, of my animals until they have been placed in accordance with the Trust created herein to care for my animals for the duration of their lives, whether or not these expenses are deductible for estate tax purposes.

**NINTH,** I hereby give, devise and bequeath the sum of    Thousand Dollars (\$-,000.00) to my Trustee hereinafter named, *IN TRUST, NEVERTHELESS*, for the following uses and purposes:

- a. To hold, invest and reinvest the same, to collect the income there from, and to pay or apply the net income there from and as much of the principal of the Trust as the person caring for such pets shall, in [his, her, its] sole discretion, request, to the support, maintenance, care and feeding of all of my animals that shall be alive upon my death in accordance with the instructions contained herein.
- b. Upon the earlier of(i) twenty-one (21) years from the date of my death or (ii) the date of the last of my animals to die, my Trustee shall transfer, assign, or pay over the then remaining principal, if any, of this Trust to or for the benefit of the Hudson Valley Humane Society for the Prevention of Cruelty to Animals.
- c. I nominate, constitute, and appoint to be the Trustee of this Trust. I direct that no bond or other security shall be required for any Trustee to qualify or act as Trustee of this Trust As soon as practicable after my death, my animals shall be delivered to \_\_\_\_\_ currently residing at \_\_\_\_\_ for maintenance and care in accordance herewith.  
If \_\_\_\_\_ shall be unable or unwilling to care for my animals,
- d. then my Trustee shall deliver my animals to \_\_\_\_\_ currently residing at \_\_\_\_\_
- e. if neither \_\_\_\_\_ nor \_\_\_\_\_ is able or willing to maintain and care for my animals, then I direct my Trustee to deliver my animals to the Hudson Valley Humane Society for maintenance and care of my animals in accordance herewith.
- f. It is my desire and wish that my animals live out their natural lives in a safe and caring environment. I wish them to continue on a raw and natural diet. I further wish my animals to receive veterinary treatment as they now receive. I direct my Trustee to insure that whoever may be caring for my animals shall abide by these wishes.

Alternate Clause:

[I nominate, constitute, and appoint the Hudson Valley Humane Society to be the Trustee of this Trust. I direct that no bond or other security shall be required for any Trustee to qualify' or act as Trustee of this Trust. {For Paragraph c.}]

[Upon my death, my executor shall deliver all of my animals to the Hudson Valley Humane Society. I direct my Trustee to find suitable and caring homes to adopt my pets. If any of my pets shall prove not to be adoptable, then my Trustee shall care for such pets for the remainder of their natural lives in accordance with my instructions herein. {For Paragraph d and e.}]

**These were provided by Ray Mundy, Rockland County Attorney, AKC Delegate for Rockland County and President, Hudson Valley Humane Society. He gave an interesting talk on what happens to your animals should you disappear from the scene. Without specific items like these in your will, it may not be pretty.**

### **AENNCHEN ANTONELLI / GILMA BLAUVELT MOSS BREEDERS AWARD**

Presented to the owner of the bitch who:

1. Produced the most champions (bred by owner from one bitch only) during the calendar year.
2. Only American Kennel Club Championships to count.

### **MILLIE MC CABE AWARD FOR STUD DOG OF THE YEAR**

Presented to the owner of the Stud Dog who:

1. Produced the most "Champions" during the calendar year.
2. Only American Kennel Club Championships to count.

### **WILLIAM KLEINMANN'S MEMORIAL AWARD**

This Award is figured from January 1, 2000 thru December 31, 2002 for the June 2003 Award. This award Will be based on the greatest number of dogs defeated in breed competition (up to and including Best in Show) by a single dog handled by its Owner. Dogs owned or co-owned by a Professional handler are excluded. If the dog is owned and banded by more than one member (neither of which is a Professional handler), both members will share the award equally.

2. Work the Match Show
3. Attend two (2) Club Meetings
4. Work at Obedience and/or Show Handling Classes
5. Work on a Club Committee
6. Participate in a Public Education Demonstration through the Club.
7. Participate in A Pet Therapy Session through the Club

*(Life Members or members living more than 60 miles from show functions are exempt)*

**In addition**, to give recognition to a greater number of members, Achievement Awards will be limited to three(3) consecutive winds by a member.
