## Lost Dogs/Cats and Scam Artists

Several years ago I had a rescue cat disappear, he got out and was just gone. I ran an ad in the local newspaper and a few days later a “long distance” truck driver called me and said he had found my cat on a road about 1/2 mile across a field from my house. He said he was on the side of the road scared and he caught him and put him in the cab of the truck. He identified the cat correctly as I asked him questions about the found cat. The truck driver said he was in Birmingham and would ship my cat to me if I wired him 100.00 dollars.

I was initially skeptical due to the fact the rescue cat was still very timid and I could not imagine him just letting someone pick him up. So instead of wiring him money I suggested that I arrange for my friends in Birmingham to meet him at a place of his choosing and they would give him 200.00 cash and take the cat. He immediately started saying he must get on the road, behind schedule, could not wait etc. I then refused to wire him money without proof he had my cat

The end of the story is that he did not have my cat I later learned via the police and news media that this is a nationwide scam.

Just a few weeks ago there was a dog lost at a local show. The handler was contacted just as I described and did indeed wire money to the person. The person that supposedly found the dog was again a “long distance truck driver” and he was in another state with the dog. The dog *was* not sent to the handler and later found in a neighborhood next to show grounds.

Here are a few hints from the Police to help avoid this type scam.

When you place an ad in the Newspaper, or put-up flyers; keep the information general. An example of what to say is: Lost orange cat near McDonald road around 3/02/99.

An example of what not to say is: Lost male Manx orange cat with collar the night of 3/02/99 has *tattoo/microchip*.

The second example gives the potential scammer too much information. The first ad will get much more attention and then you can ask leading questions of the rescuer.

Here again are some examples of correct questions.

Do you have a female cat? The scammer would answer-Yes. Then you would say “well sorry that is not my cat, he is a male.”

Do you have a cat with a busy tail? The scammer would say- Yes. Then again I would have known it was not my cat. My Manx did not have a tail.

Is there a tattoo on the inside of left ear? Answer from scammer-Yes, Again, this is not my animal-he does not have a tattoo.

Did he have a red collar on? Answer from Scammer is -Yes. Well no that is not my cat his collar was blue?

I hope you get the idea. You ask question trying to make the scammer answer wrong. If someone has truly found your lost cat or dog they will have the right answer.

If you are contacted try and get a number from your caller or some way of tracking this type person. Just remember that there are terrible people that will take advantage of other people in search of their lost pets.

"When Dogs Must Fly" March 9, 2003

'DOG owners often struggle over what to do with their pets 'when they travel. But though many pet owners and breeders 'happily fly their dogs hither and thither, there also 'exists a vocal contingent of animal rights activists who strongly discourage the practice. The American Society for 'the Prevention of Cruelty to Animals and the Humane Society 'warn of the dangers of flying dogs in the cargo holds of 'planes .including overheating or freezing, suffocating and 'being mishandled, lost or loose .and suggest avoiding it 'if possible.

“‘It’s a hit or miss thing .like playing Russian roulette,’ ‘said Lisa Weisberg, A.S.P.C.A. senior vice president for ‘government affairs and public policy. “Your dog could ‘arrive fine or not at all” Yet each group acknowledges ‘that sometimes flying with your dog is practically ‘unavoidable, and therefore each offers advice on how best ‘to keep Fido safe.

'In the Cabin

'Animal experts agree that the best way for your dog to fly 'is with you, in the cabin. Except for Southwest Airlines, 'which does not fly animals at all, the major airlines allow pets that meet certain conditions to be carried on as hand 'luggage. Most allow only one to two per cabin per flight; 'reservations are required, and the dog must be in a carrying case approved by the Department of Agriculture; 'many over-the-counter ones qualify. The container must be ~big enough for the dog to stand in but small enough to lit 'under the seat in front of you. The maximum size is about ~23 inches by 14 inches by 9 inches, which translates into a ~dog of 20 pounds or less, but may vary by airline.

'Some airlines and destinations may require that a veterinarian issue a health certificate within 10 days of 'transport; no airline will fly dogs under 8 weeks of age. 'The airlines ask that only well-behaved dogs that do not 'haw an offensive odor, bark a lot or require constant 'attention be taken on board. Taking a pet out of the case 'during the flight is not allowed. Some airlines do not 'allow carry-on pets on trans-Atlantic flights.

'If you cannot carry your dog on board, either because the 'cabin pet space is booked or because the dog is too big to 'fit under your seat, the major airlines, except Southwest, 'will allow you to check the animal as luggage in the cargo 'hold. Because many plane bellies are pressurized but not 'temperature-controlled and because flight delays are 'unpredictable, the airlines do haw restrictions on when 'dogs can fly.

'Delta and American will not ship dogs between May 15 and 'Sept. 15, when heat can be extreme, or if the temperature 'drops below 45 degrees at the destination. United will not ship an animal when the temperature is forecast to exceed '85 or to drop below freezing, and US Airways may place an 'embargo on animals at any time due to extreme heat.

'Some airlines will lilt the winter restrictions with a 'certificate from a veterinarian issued no more than 10 days 'before departure stating that the dog can withstand 'temperatures lower than 45 degrees for a prolonged period. 'Certain dogs .including adult pit bulls, Doberman 'pinschers, American Staffordshire terriers, bull terriers 'and Rottweilers .are embargoed on some airlines, and more 'stringent weather restrictions can be applied to 'shod-nosed dogs with the potential for breathing problems, 'like pugs, boxers and Shih Tzus. The airlines do not allow 'pets to be checked at curbside, and recommend that 'passengers checking animals arrive a bit earlier than 'usual. Fees range from \$75 to \$100 on most airlines, but 'Continental charges \$99 to \$329, according to weight. (The 'fees help pay for its new Pet Safe program, which includes 'personal handling in climate-controlled vehicles and a '24-hour animal help line for information and tracking.) 'International rates vary, as do restrictions on an

animal's 'entry to a state or country. Its a good idea to check with 'the state's agriculture department or the country's 'embassy.

Also, each airport may have its own temperature 'regulations. The airlines recommend that you inform yourself before flying and contact the freight department a 'day before departure and again on the day of departure to check the forecast. A hot or cold spell at either end could put an end to your dogs vacation plans.

'Pet owners who fly regularly with dogs learn to nag, 'according to Trudy Kerr, a small breeder in Calgary, 'Alberta, and the host of trawling dogs.com, a dog lovers' 'Web site. She recommends that you keep asking "Is my dog on? Can you check to see if he's O.K.~ by radioing the 'baggage crew while still on the ground.

'The airlines maintain that they follow all requirements of the Animal Welfare Act, a 1966 act of Congress (with many 'amendments) outlining the proper treatment of animals during transit. The Air Transport Association, the 'airlines' industry organization, says that its own well-publicized estimate that some 99 percent of the >500,000 animals flown per year arrive without problems was 'misconstrued to mean that 1 percent, or 5000, are lost, injured or killed. They say the number reflects only trips 'with problems, which often means the animal does not fly at 'all because of weather or lack of a health certificate or improper crate. The A.T.A., along with serious animal 'experts, offers advice on how to make flying safer for your dog. 'the rules say they will force the airlines to take better care of pets. Opponents, including the airlines and the American Kennel Club, say the demands are onerous and too expensive.

If the rules are adopted, according to Michael Wascom, Air 'Transport Association spokesman, they will probably cause some airlines to stop carrying pets altogether.

### **Making Flying Safer**

Get the dog a medical Checkup before travel and make sure 'all vaccinations are up to date, especially for dogs over 7, which should have liver and kidney functions checked.

Make sure your dog is wearing a collar with a tag giving 'both its name and your name and address.

Book a direct flight if possible.

Use a U.S.D.A.-approved shipping crate big enough for your dog to stand, sit and 'change position comfortably. Make sure the crate fastens 'securely so the animal cannot escape, but do not lock it. 'Line the bottom with towels for comfort and to absorb 'accidents. Write "Live Animal" on top of the crate and use 'arrows to indicate which side is up. Freeze water in a bowl 'secured to the crate so it will not spill during loading 'but will soon melt for drinking.

Do not tranquilize the dog, which can hamper breathing. If 'it is necessary, check with a vet.

Be a pest. Tell every airline employee you see that your pet is in the cargo hold so that added considerations or attention can be provided during loading and unloading.

Ask to watch your dog being loaded on and off the plane.

If there are extended layovers or delays, ask that the dog 'be taken off the plane or tarmac.

Additional comfort to pet owners may be on its way via the 'Federal Aviation Administration, which has proposed that 'the airlines be required to report to the public all animal
